

The Certified Quality Management System has been functioning efficiently at the Kyiv National University of Trade and Economics during 10 years in accordance with the international ISO 9001:2015.

The sphere of science in the University is an essential component of its innovative activity. The directions of scientific researches are defined according to the nation-wide priorities of science and education development with respect to the activity profile of the University. Most of them are aimed at: solving the problems of the development of merchandise turnover, trade, consumer market development management; forming foreign economic policy of Ukraine; development of competitive environment in the conditions of innovative economic model; improving the methodology of the innovation investment management under conditions of sustainable economic development, the efficiency of the budget system functioning; developing the hotel and tourism business market in Ukraine, quality assurance and product safety.

There are 7 Specialized Academic Councils in KNUTE that have the right to consider and conduct the thesis defense for the academic degrees PhD and Doctor of Sciences (Economics, Engineering, Psychology and Public Administration).

KNUTE structure also includes: Institute of Higher Qualification; Research Institute of Finance; European Education Center; Preparatory Department for Foreign Citizens and Stateless Persons; Technology Transfer Center; Scientific-and-Technical Center for Certification of Products; Center of Preparation for External Independent Testing, Services and Quality Systems; Distance Learning Laboratory; Educational and Psychological Research Center; Career Development Center; Business Training Center; Evaluation and Monitoring of Knowledge Center, Business Incubator; Training and Production Center "Rest.Art.Kitchen" etc.

KNUTE provides teaching English/French/German – as a first foreign language, and Polish/Spanish/Modern Greek/Latin – as a second foreign language. Free of charge program of studying Japanese has been functioning for more than 10 years in KNUTE.

Students of KNUTE, first of all the Faculty of Restaurant, Hotel and Tourism Business, annually undergo the practical training in the best hotels, tourist-recreational complexes and other enterprises of France, Bulgaria, Slovakia, Greece, Turkey etc.

The Library fund counts over 1,4 million printed sources from various branches of science. There are 6 reading-halls, 7 lending libraries, co-working KNUTE-HUB, multimedia library, foreign literature hall, cards and electronic catalogues hall, new literature hall, and such special sectors as methodological sector of KNUTE, thesis' and thesis abstracts sector for library users.

Institute of Higher Qualification is a structural subdivision of KNUTE, which has been implementing important activity directions for business sphere for more than 15 years. IHQ successfully competes in the segment of postgraduate and business education.

Activity of European Education Center is aimed at realization of academic mobility principles and creation of a possibility for students to get a double degree diploma. The highly qualified lecturers of EEC prepare second- and third-year students of KNUTE to pass DELF/DALF, IELTS, TOEFL levels B2, C1.

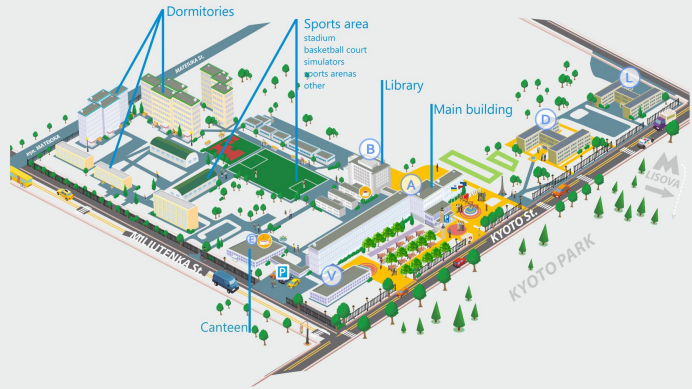

## The main facts
